SCRIP PROGRAM AGREEMENT 2022-2023

ASCS SCRIP (referred to herein as “we”, “us”, and “our”) sponsors a Scrip program which allows you to purchase Scrip. The Scrip you purchase through the program generates rebates from participating retailers. These rebates can be used as a credit to the Annual Family Fee (formerly known as the Scrip Usage Fee) assessed as part of the total amount due from school families each academic year, as a contribution to school or church, and/or as cash back to you.

Scrip is the largest ongoing fundraiser for ASCS and helps significantly with the needs of operating our school. In order to maintain a functioning/sustaining Scrip program, we incorporate an Administration Fee of 8% on all Scrip transactions. This Administrative Fee is kept by the program and, in essence, helps to replenish the lost revenue from the cash back option.

For example, currently if one receives 10% profit on a \$100 purchase of a Scrip card, that purchaser would then have \$10 applied towards his/her Scrip (Annual Family Fee) profits. Now, with the 8% Administration Fee assessed to the profits, that original \$10 amount would instead be \$9.20, or \$0.80 less.

Our Scrip program distributes rebates to families one time per year near the end of May or early June. **By not returning your form/making selections; a default will be selected for you. After fulfilling the \$500 Annual Family fee, 50% will go towards tuition next school year and 50% of the rebate will be donated back to All Saints Catholic School.** You agree to indemnify us against any loss incurred in connection with there being insufficient funds in your account to cover checks you issue to pay for Scrip. We make no representations or warranties of any kind with respect to the Scrip. This agreement continues unless replaced by another for the duration of the current academic year and can be terminated by either party upon 60 days advance notice to the other.
